

LAST WILL AND TESTAMENT

THIS WILL is made and executed on this ____ day of _____, 20____, at Pune, whereby:

future, not specifically mentioned above, shall pass to my wife, [Wife's Full Name].

4I) In the event of my wife's death before the operation of this Will, and during my lifetime, in the event of my surviving daughter, all properties and rights bequeathed to my wife shall pass to my daughter, [Daughter's Full Name], and shall be inherited, owned, and possessed by her.

5. EXECUTOR OF THE WILL:
